- The Bid Security as mentioned above in shape of Pay Order / Bank Guarantee in favour of TMC(Mauripur) shall must be enclosed with tender documents without which the tender will be treated as cancelled.
- The Contractors must mention their complete and correct present/postal address in tender documents and quote the rates both in-words and in-figures. Incomplete / Conditional tenders will be not accepted. In addition the bidders must furnish the documentary evidence against each eligibility as well as minimum qualification criteria as included in the Bidding Documents. Otherwise their tenders will be summarily rejected without consideration of their bid amount.

6. The successful bidder will furnish a performance guarantee at the time of agreement in shape of Pay Order / Bank Guarantee equal to 5% of sanctioned cost. This Guarantee will be released after completion of work.
7. An amount to 5% of Contractual Value will be deducted as Retention Money as per condition of contract which will be released after successful expiry of maintenance period.
8. The tender documents can be had from the Office as mentioned above on any working day during Office Hours except the date of opening.
9. All the tender shall be dropped on as per above schedule upto 11:00am and will be opened by the Tender Opening Committee in the Office of Executive Engineer (B&R), TMC(Mauripur), District Keamari, Karachi at 11:30pm in presence of the Contractor who wish to be present.
