- ii) Documentary evidence of minimum 3 works of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
- iii) The bidder should have experience of such works and should have completed at least 2 No's similar nature of works in last three years (List to be provided with bid).
- iv) VALID Electrical License issued from Inspectorate of Electrical License Sindh of the similar region with respect to works shown above.
- v) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- vi) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- vii) Annual turnover must be equal as per estimated cost or above for the last three years.
- viii) The application shall accompany of tender fee as shown against each for purchase of bidding documents.
- ix) The 2% Earnest money shall be submitted in shape of Call Deposit / Pay Order/ Demand Draft from any scheduled Bank of Pakistan in favour of Executive Engineer, Provincial Buildings Division-I, Karachi.
