MANDATORY CONDITIONS:

- i- Method of Procurement: Single Stage Two-Envelope Procedure (must contain two separate sealed envelopes with signed stamp of firm for Technical Proposal" and "Financial Proposal" otherwise such tender will not be entertained).
- ii- Financial Proposal will be opened for those firms only who qualify the mandatory requirements.
- iii- Bidder should be registered with Pakistan Engineering Council (PEC) in relevant category supported by PEC valid registration certificate.
- iv. Bio data of Engineering and Technical staff working with the firm along with Attested CVs and their Income tax Deduction showing employment with the firm.
- v. At least two (02) works / schemes similar nature & cost or more in last five (3) years along with completion certificate of Respective Department showing total cost of works along with colored photographs (at least four (04) photographs each).
- Vi. An original and latest undertaking / Affidavit on Judicial paper that the Bidder and its employees have never been blacklisted by any Government, Semi Government, Autonomous or State Owned Organization and their cases regarding blacklisting are not under trial by any court of Law.
- Vii. Contractors are bound to quote workable rates, failing which they will be blacklisted in future tendering.
- Viii. The conditional tenders will not be accepted and the procuring agency may reject all or any bids subject to the relevant provisions of the SPPRA Rules.
- IX. The successful contractors whose tenders are accepted will have to obtain adhesive stamps from assistant superintendent stamps, Government of Sindh, and payment of fees according to schedule in the Sixth finance Act 1996 amended rule 2015 and sign the agreement.


- a. Average annual turnover should be at least Five Times of Bid in last Three (03) Years (For marking purpose).
- b. Available Bank Credit line shall be at least 35% of the Bid cost (verifiable) (For Marking purpose).
- c. Registration with Income Tax Department (NTN Certificate should be attached) and Sindh Revenue Board (SRB Certificate should be attached) supported by copies of Income Tax return receipts of the last three (3) years. Must be active tax payer status.
- d. Litigation history in which the decision has been given against or in favor of the firm (s). List and give brief details of arbitration / litigation / court cases if any in case of no such cases enclose an affidavit that the firm has not been involved in any litigation arbitration with any Government Departments.
- e. **List of machinery and equipment available with documentary proof of its ownership / Rented (For Marking).**
- f. Electrical Works carried out during the last Three (3) years by the contractor/ associates/ subcontractor. **The list of works must be submitted with the tender documents including work order.**
- g. Bank Account Statement in the name of the Bidders Firm for the last three (3) years **must be submitted with the tender documents.**
- h. Copy of valid Electrical License in the name of Firm / associates / sub-contractor renewed up to date from Electrical Inspector -Government of Sindh, **must be submitted with the tender documents.**
- i. Copies of annual audit report for the last three years duly certified by the Chartered Accountant verifiable, **with the tender documents.**
- j. Affidavit to the effect that the all documents/particulars/information furnished are true and correct, if any information found incorrect/misleading the Procuring Agency reserves the right to reject the bid.
- k. The application shall accompany of tender fee Rs.3000 / as shown against for purchase of bidding documents, in favour of the undersigned.
- l. The 5% Earnest Money shall be submitted at the time of technical & financial proposal in the shape of call deposit/ pay order issued from any scheduled bank along with the bid in favour of the undersigned.
- m. Conditional tenders will summarily have rejected.
- n. Advertisement can be seen on SPPRA /PPMS website.
- o. Tender will be opened at 10:00 A.M by the Procurement Committee & undersigned in the presence of contractors are their authorized agents who were present at the time.
